

THE ACE TRUCK GROUP



THE ACE TRUCK GROUP is comprised of individuals, trusts and companies who wish to ensure that the operations of ACE Africa are as effective as possible, by funding its fleet of vehicles.

THE ACE TRUCK GROUP provides additional and replacement vehicles to transport ACE Africa's professional team in its work in poor rural districts of East Africa, presently in Kenya and Tanzania. The preferred model is a dual cabin pick-up truck which can transport our team members, community volunteers and beneficiaries, as well as supplies for our agriculture and nutrition, medical support and household support activities. In some districts ACE Africa also uses vans. Vehicles are selected based on service and spares availability as well as suitability for the rough roads and tracks that are encountered. Typically new vehicles cost £25,000 and last about six years. If necessary on cash flow grounds second hand vehicles are bought, which cost much less but which obviously have a shorter life. At present ACE Africa has a requirement for four vehicles and has a fleet of three two of which need replacement. The programme in Tanzania does not have its own vehicle and is relying on a member of staff's car.

THE ACE TRUCK GROUP members are asked to make an initial contribution on joining towards the capital costs of additional and replacement vehicles and an annual subscription of at least £480 with Gift Aid or £600 without Gift Aid towards the replacement of the fleet. The whole of these contributions and subscriptions without deduction goes directly towards the purchase of vehicles
